# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORSICANA, TEXAS AMENDING THE FISCAL YEAR 2023 BUDGET.

**WHEREAS**, the City Council of the City of Corsicana, Texas, adopted Ordinance No. 3119 on August 22, 2022, approving expenditures for the fiscal year ending September 30, 2023, pursuant to the laws of the State of Texas; and

**WHEREAS**, budget adoption included purchases through lease/purchase in the amount of \$1,453,075; and approved lease/purchases are shown on page 238 of adopted budget document; and

**WHEREAS**, the City prepared and received RFP's for lease purchase funding, and received one proposal for funding, with overall interest payments of \$157,103; and

WHEREAS, it is necessary to amend the Fiscal Year 2023 adopted budget.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Corsicana, Texas that:

- **Section 1.** The Fiscal Year 2023 budget shall be amended to reflect that the City will purchase and pay for the approved lease/purchase items, rather than fund through a lease/purchase agreement.
- **Section 2**. This amendment will increase expenditures in Fund 100 by \$1,006,129; will increase expenditures in Fund 501 by \$446,946; and decrease Funds 411 and 412 by \$359,897.
- **Section 3.** This amendment will save interest in Fund 100 (\$114,034); and in Fund 501 (\$43,069).
- **Section 4.** This amendment will decrease debt outstanding by \$1,453,075; and the commitment to make a lease/purchase payment for Fiscal Year 2023 for Fund 411 (-\$233,373) and Fund 412 (-\$126,524).
- **Section 5.** A true and correct copy of the Amended Budget is hereby directed to be filed in the office of the City Secretary, and said Amended Budget is made a part of this Ordinance by reference as though fully copied herein verbatim.
- **Section 6.** It is being deemed by the City Council that this Ordinance shall go into immediate effect and force after its passage, approval, and publication according to law.

**DWI Toxicology Blood Kits** 

**Comments:** The City of Corsicana Police Department has previously ordered DWI toxicology blood kits from WorkQuest. WorkQuest is the company that is in charge of DWI toxicology blood kits for all of Texas. The policies have changed since the Police Department last placed an order. There are now two options for purchasing the kits.

#### Option 1

An account/membership would be created for the City of Corsicana. The account would have to be in the name the City (Superuser) with the Police Department as a sub-user to conduct the business. Kits could then be purchased through the Texas Comptroller of Public Accounts website known as SmartBuy and shipped to the Police Department for \$7.25 each with free shipping.

#### Option 2

Someone would need to drive to the office in Austin and purchase the kits in person with a credit card at a cost of \$8.00 each.

Option 1 would be more cost and time efficient. The resolution is to request approval for the City of Corsicana to apply for a membership account with the Texas Comptroller of Public Accounts Texas SmartBuy Marketing Coordinator Outreach Program for the purpose of ordering and purchasing DWI toxicology blood kits.

**Recommendation:** Approve for the City to apply for a membership account to purchase DWI toxicology blood kits.
